

## Competition Terms & Conditions

**If you participate in any Classic Hits 4GY competition, there are a few rules that you must agree to before entering. Upon entering and competition on Classic Hits 4GY via phone, website, email, or by any other means, it is to be considered that you accept and agree to abide by all Terms and Conditions.**

The following General Terms and Conditions apply to all Classic Hits 4GY and Super Radio Network competitions:

- Classic Hits 4GY reserves the right to amend these General Terms and Conditions at any time without notice.
- Special Terms and Conditions may apply to a particular contest, at which time, separate Terms and Conditions will be available for the contest involved.
